Market hours of operation are 9am until 2pm. Vendors will remain set-up during operating hours and any activity outside of these hours is strictly prohibited without written approval.

No combustible material permitted. No weapons, no pornography, no alcohol or tobacco to be offered for sale.

Vehicles are not permitted in the outdoor selling area. All vendors will set up and tear down in a swift and efficient manner to minimize disruption to vehicle and pedestrian traffic.

No signs will be placed in the premises or outdoor areas without explicit permission.
